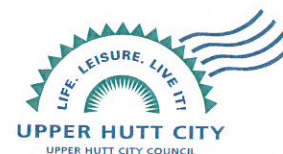

The specific provisions of the proposed Plan Change that my submission relates to are as follows:  
 33.1 Mangaroa Flood Hazard Extent Rules.  
 23.21 Earthworks in the Erosion Hazard Area of Mangaroa Flood Hazard Extent  
 23.1 Earthworks in the Mangaroa Flood Hazard Area

My submission is that:  
 The submission seeks that 33.1, 23.1 and 23.21 be amended to allow for the development on properties of dwellings where that land had been subdivided prior to notification of this plan change. The Plan change unduly restricts development on 43 Mt Marua Drive to an extent not necessary or reasonable. Yard set backs and the erosion hazard area means no real 'buildable' area left on the site which has previously been assessed in terms of section 106. Subdivision of the site previously has given perception of a right to build which this PC removes. I will further comment on my reasons for wanting amendment to the provisions at the hearing.


I seek the following decision from the local authority:
