# Creative Communities Scheme

Creative NZ / Upper Hutt City Council

## What is the scheme about?

Funds to enable more sustainable careers, encourages innovation and the development of arts practice, and provides opportunities for diverse communities to access the arts.

## What is funded?

Each year Creative New Zealand provides funding to city and district councils to distribute in their area to fund local arts projects. The scheme supports more than 1,800 projects every year. Most grants are under \$2000.

## What vision does the scheme support?

- To create opportunities for local communities to engage with, and participate in local arts activities
- To support the diverse artistic cultural traditions of local communities
- To enable young people (under 18 years) to engage with and participate in the arts

## Who is eligible?

Applicants can be an individual or a group. Individuals must be New Zealand citizens or permanent residents. If an applicant has already received CCS funding for a project, they must complete a report on that project before making another application, unless the project is still in progress.

2023/2024 - Second Round - Open 4 March - 14 April 2024

2024/2025 - First Round - Open 12 August - 13 September 2024

# Community Organisation Grant Scheme (COGS)

Te Tari Taiwhenua /The Department of Internal Affairs

## What is the fund about?

Funding that provides grants to non-profit organisations delivering community-based social services that contribute to achieving locally determined outcomes.

## What is funded?

- The running or operational costs of organisations that provide community-based social services
- Community development costs, such as hui, training, planning, evaluation and facilitator fees
- Community projects or event costs that encourage participation in communities, promote community leadership, and/or promote social, economic and cultural equity

## What vision does the fund support?

- Encouraging participation in communities
- Promoting community leadership
- Developing community capability
- Promoting social, economic and cultural equity, or
- Reducing the downstream social and economic costs to communities and government.

## Who is eligible?

In the Hutt Valley, higher priority will be given to grassroots organisations that:

- demonstrate a clear local footprint and/or
- support whanau (pepe to kaumatua) with mental, physical, emotional and/or social wellbeing in the Hutt Valley community and/ or
- promote community leadership and/or capability in the Hutt Valley community
- promote cultural identity and/or equity in the Hutt Valley community
- Lower priority will be given to national organisations with limited benefit in the Hutt Valley

Open April –May 2024

# Ethnic Communities Development Fund

Te Tari Mātāwaka / Ministry for Ethnic Communities

## What is the fund about?

This fund has \$4.2 million a year available for projects that support ethnic communities to grow their skills, celebrate their culture and take part in society. The fund is also available for initiatives that support ethnic communities as they deal with the challenges of COVID-19.

## What is funded?

- Projects that support ethnic communities in New Zealand
- Groups with legal status (including trusts and incorporated societies) can apply for over \$10,000
- Groups without legal status can apply for up to \$10,000

## What vision does the fund support?

- To promote the value of diversity and improve the inclusion of ethnic communities in wider society
- To ensure government services are provided equitably and in ways that are accessible for ethnic communities
- To improve economic outcomes for ethnic communities, including addressing barriers to employment
- To connect and empower ethnic community groups

## Who is eligible?

Groups that support ethnic communities in New Zealand - these communities include migrants, former refugees, long-term settlers, and multi-generational New Zealanders who identify as:

- African
- Asian
- Continental European
- Latin American
- Middle Eastern

# Lottery Community Grant

Te Tari Taiwhenua /The Department of Internal Affairs

## What is the grant about?

Funding for not-for-profit organisations with a community or social service focus for ongoing operating costs or projects which help improve the quality of people's lives in their communities.

## What is funded?

Lottery Community grants may be one-off contributions or multi-year grant investments for up to three years, for:

- ongoing operating costs for existing or expanded services and activities
- projects beyond an organisation's day-to-day operations
- helping to top-up an organisation's existing funding
- minor capital works projects where the total project cost is \$50,000 or less.

## What vision does the grant support?

Lottery Community funds organisations that support the needs of:

- Māori, whānau, hapū and iwi
- Pacific people and other ethnic communities
- older people, women, youth and people with disabilities.

## Who is eligible?

In Wellington/Wairapa, higher priority will be given to service providers that demonstrate collaboration, a actively engaged and contributing to the following social outcomes in their community:

- Rangatahi/young people are empowered, engaged and inspired.
- Vulnerable people are connected to their communities and are thriving.
- Wellbeing and connectedness within communities is enhanced.
- Māori, Pasifika and Ethnic Communities are empowered, connected and achieving their aspirations.

Open June –July 2024 and Open Oct –Nov 2024

# Lottery Community Facilities Grant

Te Tari Taiwhenua /The Department of Internal Affairs

## What is the grant about?

Funding for to improve or build new community facilities, or for feasibility studies to examine plans to improve or build community facilities can be achieved and will benefit the community.

## What is funded?

- projects where the total project cost is over \$50,000
- projects to build new community buildings or facilities
- projects to improve or enlarge existing community facilities
- feasibility studies to work out if planned projects are needed, can be achieved and fit the long-term vision for the community
- Seismic assessments.
- building purchases (but only if this is a better and less costly option than building a new facility).

## What vision does the grant support?

The aim is to get more people involved in community and social activities, and to strengthen communities and bring people together by helping to develop their community facilities.

## Who is eligible?

The Committee is more likely to fund requests that show the project:

- has strong governance and financial management
- involves tradespeople who are qualified or experienced to do the work
- meets all of the regulations and requirements for building, health and safety
- provides access for disabled people
- provides essential services, such as plumbing, wastewater and sewerage systems, and electricity and fire protection
- has support from your community, such as people ready to work as volunteers

Open 3 Jan – 28 Feb 2024

# Lottery Minister's Discretionary Fund

Te Tari Taiwhenua /The Department of Internal Affairs

## What is the fund about?

Funding for one-off grants to not-for-profit organisations and individuals for projects that fall outside the scope of the Lottery Grants Board distribution committees. The Lottery Grants Board also provides funding for natural disaster emergencies recovery through the Lottery Minister's Discretionary Fund.

## What is funded?

- Overseas travel (incl. attending international, web-based events and conferences remotely)
- Web-based events and attending remotely
- Volunteer firefighting and emergency ambulances services projects
- Animal welfare projects
- Learning and development projects
- Financial planning and/or good governance training
- Te Tiriti o Waitangi and Te ao Māori training
- One-off learning and development projects where two or more community organisations benefit

## What vision does the fund support?

As well as considering funding requests for projects that fall outside the scope of other Lottery funds, the Lottery Minister's Discretionary Fund has four priority areas which are not covered by other Lottery funds.

## Who is eligible?

Individuals and community groups whose projects that fall outside the scope of other Lottery funds.  
Note: individuals can only request funding for overseas travel

## Application Dates

Ongoing – monthly intakes

# Whenua Māori Fund

Te Puni Kōkiri / Ministry of Māori Development

## What is the fund about?

Whenua Māori Fund supports whenua Māori based economic, cultural, social and environmental projects which help strengthen whānau, communities, regions and the New Zealand economy

## What is funded?

Applicants should contact their nearest Te Puni Kōkiri regional office, so staff can help discuss their ideas for developing their whenua

## What vision does the fund support?

- To assist Trustees and owners of whenua Māori to explore the potential of their whenua
- To investigate the means of lifting productivity, either through improving and growing existing operations, diversification, or preparing for new ventures

## Who is eligible?

- Your whenua must be Māori freehold land. Your whenua must have a governing entity unless there are seven or fewer owners
- If there are seven or fewer owners, each owner must be supportive of an application to the Fund

# Tū Manawa Active Aotearoa Fund

## Nuka Ora

### What is the fund about?

Nuka Ora's Tū Manawa Active Aotearoa Fund provides funding for programmes or projects delivering play, active recreation, and sport experiences for tamariki and rangatahi. These may be new or already operating.

### What is funded?

Venue or equipment hire, costs of transport to the event, support for volunteers / activity delivery staff, equipment and/or officials, promotional costs

### What vision does the fund support?

- Nuka Ora is the independent body for physical activity in the greater Wellington region. Established in 1990 with charitable status under the Charities Act, they believe physical activity has the power to transform lives.
- They are a Regional Sports Trust (RST) dedicated to improving the wellbeing of the communities they serve.

### Who is eligible?

- Hapū, Iwi, Marae, Māori organisations
- Incorporated Societies
- Charitable Trusts
- Regional or Local Council
- For-profit businesses/commercial organisations and social enterprises
- Education settings: Primary / Intermediate schools / Kura / Secondary schools / Wharekura / Tertiary Education / Whare Wānanga

- Smaller Project Fund – (Round 3) - 13 January - 3 February 2024

# Aotearoa Gaming Trust

## What is the organisation about?

Aotearoa Gaming Trust funds many varied community groups from large national organisations through to smaller local groups with “any charitable, philanthropic, cultural, or educational purpose, or any other purpose that is beneficial to the community.”

## What is funded?

- Operating costs may be considered to support community organisations. This may include salaries, plus general overheads such as rent, power, and phone
- Project cost grants may be available to assist funding to community projects, events, assets or programmes

## What vision does the organisation support?

To connect with communities to ensure the funding they provide empowers those communities and provides community well-being and positive outcomes for the people.

## Who is eligible?

They only accept applications from not-for-profit organisations – see website for specifics.

# The Lion Foundation

## What is the organisation about?

The Lion Foundation is one of New Zealand's oldest and most respected Charitable Trusts. Since 1985 we have returned over \$1 billion back to the community, supporting thousands of good causes all around New Zealand.

We have many Lion Foundation venues and gaming machines across the country and we consistently return millions of dollars into the community.

## What is funded?

We fund a wide range of expenses, including for example, administration and operating expenses, capital expenditure, equipment, travel expenses and playing apparel. We are unable to consider grants for retrospective costs, food, drink or catering, fuel and mileage, bar renovations or fittings, koha, cell phones, individuals, first aid kits, footwear, training kit, warm up gear, socks, sport bags and professional sport.

## Who is eligible?

In order to successfully obtain a grant, your organisation must be incorporated (e.g. under the Incorporated Societies Act, Charitable Trusts Act or other legislation). It must also have Charities Commission registration or an IRD income tax exemption (e.g. for sports bodies as a body promoting amateur games and sports). – see website for specifics. <https://lionfoundation.nz/criteria-for-applications/>

# Pelorus Trust

## What is the organisation about?

The Pelorus Trust is a charitable Trust based in Lower Hutt that raises funds for charitable, philanthropic and sporting purposes through the operation of gaming machines

## What is funded?

Funds may be distributed to any cultural, philanthropic, charitable, sporting, educational or any other purpose that benefits the community or section of it. The majority of applications received are from amateur sports clubs, which is then reflected in their funding pattern.

## What vision does the fund support?

To maintain an open and equitable funding regime that enables non-profit organisations such as sports clubs, cultural groups, and community-based societies or trusts to apply for funds through a transparent and efficient application process

## Who is eligible?

- Any charitable, sporting or other community-based organisations
- Grants will be made to recipients that are located in the general geographic area from which the funds were raised

## Application Dates

Applications are accepted at any time and allocation meetings are generally held twice each month

# Pub Charity

## What is the organisation about?

Grants to assist community organisations in New Zealand through the funds raised in gaming machines hosted in Pub Charity member hotels and taverns

## What is funded?

Any purpose which or the time being constitutes a charitable purpose in New Zealand, including:

- The advancement of education
- The promotion of scientific research and learning
- The promotion and support of the relief of poverty, including physical welfare
- The promotion and support of other purposes beneficial to the community, including literature and the arts
- The promotion and support of all codes of amateur sport
- A non-commercial purpose that is beneficial to the whole or a section of the community

## What vision does the fund support?

To support a large number of organisations from across the spectrum – community groups, health, sport, education, emergency services, environment, culture – all receive equal consideration. The funds return to the communities where they were raised to ensure they are the ones that benefit.

## Who is eligible?

Non-profit incorporated organisations providing enduring or demonstrable community benefit by promoting charitable purposes or amateur sport. Applications from communities, welfare groups and organisations will need to be within one of the following groups:

- Education (including pre-school, kindergartens, playgroups, Ngā kōhanga Reo)
- Fire brigade, ambulance, or lifesaving
- Health, and health related purposes
- Youth

Applications are accepted every month except December – specific dates can be found on the website

# TAB New Zealand

## What is the organisation about?

TAB NZ provides funding to support racing and amateur sports organisations across New Zealand through Class 4 gaming venues in the local communities

## What is funded?

For amateur sport - costs associated with and/or the enabling of the direct participation in sporting activities will be given higher priority. For example:

- pooled resources like player's equipment and/or playing uniforms
- purchase, maintenance or repair of playing surfaces and/or equipment
- hiring of sporting facilities or grounds
- travel and/or accommodation costs associated with participating in (domestic) tournaments

## What vision does the fund support?

To encourage active participation in New Zealand amateur sports by distributing up to 20% of its net proceeds to communities in accordance with its Sports Authorised Purpose.

## Who is eligible?

- Individual amateur sports clubs or similar organisations at a local or regional level
- Regional or national amateur sports organisations to which individual amateur local sports clubs or similar organisations are affiliated or formally aligned
- Local, regional or national organisations which facilitate the active participation in New Zealand amateur sports through the provision of sports facilities, sports tuition, refereeing or umpiring
- Other regional or national organisations which facilitate the active participation in amateur sports by providing general co-ordination and oversight of, or other assistance to, one or more sports and/or all clubs or organisations participating in one or more sports.
- The applicant must be an incorporated society/registered charity, be open to the public and affiliated to a sport recognised by Sport New Zealand.

# The Trusts Community Foundation

## What is the organisation about?

TTCF is a not-for-profit company established primarily to distribute the profits generated from Class 4 gambling machines operating in bars and restaurants in many parts of New Zealand

## What is funded?

Costs associated with and/or the enabling of an Authorised Purpose which may include;

- Charitable purposes which advance education
- Supports the relief of poverty
- Is beneficial to the community and environment
- Promotes cultural activities, amateur sports, arts and literature

## What vision does the fund support?

They see local community groups and organisations as the backbone of any region and they are pleased to be a part of providing them with as much support as they are able.

## Who is eligible?

- Non-profit organisations operating in the local community where TTCF has a gaming venue
- Note: does not generally approve grants to new organisations that have been operating for more than twelve months and can demonstrate they have the ability to set up, maintain and provide their service delivery without total reliance on only one source of funding.

# Trust House Foundation

## What is the organisation about?

Funding for community events and organisations through grants via this licensed Class 4 Gaming foundation

## What is funded?

Projects which promote, advance, or encourage education, science, literature, art, physical welfare, or recreation, or any other purposes that are beneficial to the community.

Organisations will be considered more favourably if they provide the following:

- Community support, including the development and wellbeing of the young and aged
- Cultural activities and recreation, including the performance and development of music, the arts, history and sport
- Welfare and social services for the prevention and/or rehabilitation of addiction

## What vision does the fund support?

To enhance the well-being of our communities by operating prosperous businesses, returning profits to the community, investing in community assets and promoting environmental sustainability

## Who is eligible?

- Local not-for-profit community, cultural, recreational and sporting groups or organisations, such as incorporated societies and registered charities
- Local branches of national not-for-profit organisations that have an association or communal interest with the communities in which Trust House Foundation have gaming machines

## Application Dates

- Grants for most areas are decided every eight weeks
- Check their newspaper advertisements and website for cut-off dates

# ANZ New Zealand Staff Foundation

## What is the organisation about?

We're one of New Zealand's leaders in payroll giving, with almost 2,000 staff contributing regular amounts from their after-tax salaries. ANZ New Zealand matches these contributions at a rate of \$2 for every \$1 donated by staff. All funds go to our charitable trust, the ANZ New Zealand Staff Foundation.

## What vision does the foundation support?

Since inception in 2000, the ANZ New Zealand Staff Foundation has distributed over \$10 million in community grants to more than 1,000 charities and community projects nationwide in a wide range of sectors.

## Who is eligible?

Registered New Zealand charities whose work fulfils one or more of the criteria below

## What is funded?

Funding criteria:

- To assist in the promotion of financial literacy.
- To provide opportunities for all New Zealanders to achieve economic and social independence.
- To provide access to learning opportunities that prepare people for meaningful work and a high quality of life.
- To assist people working together to create viable and secure communities.
- To assist communities to conserve New Zealand's natural and historic resources.

**Note:** A maximum of \$25,000 can be requested by each charity per funding round. Charities without audited accounts can apply for a maximum of \$12,000.

## What is not funded?

- Normal operating and administration costs, including salaries. However, consideration will be given to funding the cost of providing specialist services, e.g. a specialist counsellor.
- Fixed assets, including equipment unless the equipment is critical to the operation of your organisation, e.g. medical equipment for a hospice.
- Schools, Sports clubs and Endowments.
- Capital investment, e.g. new buildings.
- Fundraising events or campaigns.
- Charitable projects that are not New Zealand based.

## How to apply?

The ANZ New Zealand Staff Foundation normally has two funding rounds per year. These are ordinarily open for applications between:

- 1 January - 5pm on 15 February, or on the next business day if 15 February falls on a weekend/public holiday
- 1 July - 5pm on 15 August, or next business day if 15 August falls on a weekend/public holiday

## What is the organisation about?

## What is funded?

## What vision does the organisation support?
